The most valuable works will also be published in the Romanian Journal of Legal Enforcement.

## REDACTING AND PUBLISHING CONDITIONS

In order to be published in the conference volume, the works must be electronically submitted to the e-mail address [conferinta@ccdsu.ro](mailto:conferinta@ccdsu.ro).

**On the elaboration of the works, it is necessary to consider the following conditions:**

- texts will be edited in Romanian language, in Microsoft Word (at least version 7.0) only with Times New Roman, the standard version, necessarily using diacritics. The font size will be 12 for the text and 10 for the footnotes (1.5 rows spacing) and the edges will all have 2 cm. The page size is A4. Paragraphs must be marked in text by paragraph or larger spacing between rows. Maximum number of pages: 50;

- each work must contain, on the first page, the full title of the paper, the name and surname of the author (s), the profession, the teaching or scientific title, the institution in which it operates, the contact details: full address, phone number;

- each work will be initially provided with a summary writing in Romanian and in an international language (preferably Russian), which should not exceed 1,000 characters and also a number of five keywords in Romanian language;

- the title of each submitted work must be written in Romanian;

- if abbreviations are used, the abbreviated word must first appear wholly with the abbreviation specified in brackets. It is recommended to distinguish between lowercase and uppercase letters, between letter o and numeral 0, between letter l and number one and between the letter K and the Greek Kappa symbol.

### **Bibliographic references:**

- the bibliographic notes included in the footer of the pages must be completely written, with the name and surname of the authors, the entire title of the work, possibly the edition and / or the volume, the publishing house, the year and place of the editing, the page / pages to which the reference is made. Where a reference is made to unpublished works, they may be quoted by specifying how the author has become familiar with those documents.

- documents available only on the Internet can be quoted with the full name of the website, which must have a fixed URL, and the link will be specified in brackets and the last consultation date. The authors are asked to check the accessibility of the link before quoting.
